DECIDING:

To stipulate: REGULATION OF THE MINISTER OF TRADE CONCERNING

PROVISIONS ON THE EXPORT OF FORESTRY INDUSTRY PRODUCTS.

article 1

In this Ministerial Regulation what is meant by:

1. Export is the activity of removing goods from customs area.
2. Forestry Industry Products are wood products preparations and derivatives.
3. Wood is part of a tree trunk contains cambium (*ligno cellulose*) not included bamboo and / or the like.
4. Verification or Technical Inquiry is research and inspection of Forestry Industry Products which conducted by surveyors.
5. Surveyor is a survey company that gets authorization to do Verification or Technical Search.
6. Access **Right** is a right granted for interact with electronic systems that are stand alone or with a network.
7. *Online Single Management and Implementing Agency Submissions* , hereinafter referred to as OSS Institutions is a non-ministerial government institution holding government affairs in the field investment coordination.
8. Main Business Number, hereinafter referred to where NIB is the identity of a business actor published by the OSS Institution after a business actor do registration.

9. Minister is the governing minister government affairs in the field of trade.
10. Director General of Foreign Trade a hereinafter referred to as Director General is Director

General of Foreign Trade, Ministry
Trading.

11. Director of Agriculture and Forestry Product Exports

hereinafter referred to as Director is the Director
Agricultural and Forestry Product Exports,
Ministry of Trade.

Section 2

(1) With this Ministerial Regulation Industrial Products

Forestry needs to be regulated for export.

(2) Forestry Industry Products as intended

in paragraph (1) are listed in Appendix I which
is an inseparable part of the Regulation
This minister.

Article 3

Forestry Industry Products as intended

in Article 2 paragraph (2) can only be exported by:

a. forestry industry companies that have NIB

and industrial registration certificate or industrial business permit;

and

b. trading company in the field of exporting Products

Forestry Industry which has NIB and Letters
Trading Business License.

Article 4

(1) Forestry Industry Products as intended

in Article 2 paragraph (2) can only be exported after
meet the technical criteria as stated

in Appendix II which is part no

integral and this Ministerial Regulation.

- (2) Forestry Industry Products made of coconut wood and Palm oil in the form of *Surfaced Four Side* (S4S), E2E or E4E, *Finger Jointed*, *Decorative Profile*, Profile wood for *Door Jamb* or Window sills (*Window Jamb*), Wood Profile for Frame Door (*Door Frame*) or Frame Window (*Window Frame*), *Wall Panel*, *Flooring*, *Decking*, *Flooring for Trucks*, *Containers*, *Ship Decks* and *Wagons*, Elements wooden building which is a unit unit from buildings, Prefabricated Buildings from Wood, *Post and Beam*, *Window Board* can be exported with no meet the technical criteria as stated in Appendix II which is part no inseparable from this Ministerial Regulation.

Article 5

- (1) In case there are Forestry Industry Products as referred to in Article 2 paragraph (2) which doubtful fulfillment of the technical criteria as is referred to in Article 4 paragraph (1), export of Industrial Products Forestry can only be done after first first received approval from the Coordination Team.
- (2) the Coordination Team as referred to in paragraph (1) stipulated by the Minister.
- (3) The coordination team as referred to in paragraph (2) consists of elements from ministries, government agencies non-ministry, or other related institutions.

Article 6

- (1) Besides having to meet the technical criteria as stated referred to in Article 4 paragraph (1), Industrial Products Forestry as referred to in Article 2 paragraph (2) can only be exported after verification or Technical Search before loading goods.
- (2) Implementation of Verification or Technical Inquiry as referred to in paragraph (1) shall be carried out by

Surveyors appointed by the Minister.

Article 7

(1) To be able to be determined as implementing Verification or Technical Tracing of Forestry Industry Products as referred to in Article 6 paragraph (2), Surveyors must meet the following requirements following:

- a. have NIB;
- b. have a Survey Service Business License;
- c. has been accredited as an Institution

Inspections from the National Accreditation Committee are appropriate with relevant scope;

- d. experienced as a Product Surveyor

Forestry Industry for at least 5 (five) years;

- e. has a branch / representative office in the region Indonesia;

- f. has a track record (*track record*) good

in terms of managing Verification activities or

Technical Search in the field of Industrial Products Forestry;

- g. has a special information technology system

implemented according to space

assignment scope and connect with

Indonesia National Single Window portal

(INSW) in a manner electronic through

<http://inatrade.kemendag.go.id>; and

- h. have a Report signing official

Surveyor

(2) To be able to be determined as implementing Verification or Technical Tracing of Forestry Industry Products as referred to in Article 6 paragraph (2),

The surveyor must submit a written application

to the Minister by attaching:

- a. photocopy of NIB;
- b. photocopy of Survey Services Business Permit;
- c. photocopy of accreditation certificate as an institution
inspection by the National Accreditation Committee accordingly
with relevant scope;

- d. statement letter containing the experience
as a Surveyor in the Verification field
Technical Tracing of Forestry Industry Products;
- e. certificate of work area
company, at least contains the office address
head office and branch / representative office;
- f. stamped statement letter containing the record
good *track record* in the field
management of Verification or Technical Search
Forestry Industry Products;
- g. certificate of having a technological system
information that is specifically implemented
in accordance with the scope of the assignment and
connected to the *Indonesian National* portal
Single Window (INSW) electronically via
<http://inatrade.kemendag.go.id>; and
- h. list of names of officials who sign the Report
Surveyors, signature examples and stamp examples
company.

Article 8

- (1) Verification or Search can be done
Technical, forestry industry company and / or
trading company as intended
Article 3 must apply

Verification or Technical Inquiry to the Surveyor.

(2) Verification or Technical Inquiry by Surveyors

as referred to in paragraph (1) includes:

a. administrative verification activities on:

1. NIB;
2. Industrial Registration Certificate or Business License
Industry, for forest industry companies;
and
3. Trading Business License, for
trading company in the export sector
Forestry Industry Products.

b. physical verification activities towards:

1. quantity, type, brand and packaging number;
2. quantity of goods;
3. type of wood;
4. fulfillment of technical criteria;
5. Check conformity between the description
goods with Tariff Post / HS based
provisions on the classification of goods;
6. supervision of loading into crates
containerized, if shipment uses
container; and
7. installation of a seal on the container if
all items in the container are checked
by surveyors.

Article 9

(1) Verification or Technical Inquiry Results

referred to in Article 8 paragraph (2) is set forth in

Surveyor Report form to be used as
customs complementary documents required
for delivery of export customs notifications
to the customs office.

- (2) Surveyor Report as intended in
paragraph (1) must contain a statement of truth for
Verification or Technical Search results
becomes the full responsibility of the Surveyor.

Article 10

- (1) For the implementation of Verification or Technical Inquiry
as referred to in Article 8 paragraph (2),
Surveyors charge fees for services of an amount
determined by observing the principle of benefits.
- (2) Costs incurred for carrying out Verification
or Technical Inquiry as intended
paragraph (1) shall be charged to industrial companies
forestry and / or trading company
as referred to in Article 3.

- (3) In the case of a forestry industry company and / or
trading company as referred to in
paragraph (1) is included in the category of small industries which own
Industrial Registration Certificate or Small Industrial Business Permit,
costs arising from Verification or activities
Technical Tracing is charged to the Government
according to the budget availability in the year

- (4) Small industries that have Industrial Registry Numbers
or a small industrial business permit as intended
in paragraph (2) can obtain cost facilitation

Verification or Technical Inquiry from the Government.

(5) Small industries that have Industrial Registry Numbers

or a small industrial business permit as intended
in paragraph (3) must meet the criteria
as follows:

- a. employ at most 19 (nine
twelve) workforce; and
- b. has an investment of less than
Rp.1,000,000,000.00 (one billion rupiah) no
including land and business premises.

Article 11

- (1) Surveyor Report as referred to in
Article 9 paragraph (1) is issued no later than 1 (one) day
after inspection of loading and unloading of goods.
- (2) Surveyor Report as intended in
paragraph (1) issued only by a Surveyor
used for 1 (one) shipment.
- (3) Surveyor Report as referred to in
paragraph (1) signed by a Surveyor official who
his signature was registered with the Ministry
Trading.

Article 12

- (1) Surveyors are required to submit Surveyor Reports
as referred to in Article 11 paragraph (1)
electronically to the Director General through
http: // intrade. kemendag. go. id.
- (2) In the event of a force majeure occurring

resulting in the electronic system referred to in paragraph (1) does not function, Surveyor Report as referred to in paragraph (1) is submitted manually to the Director General.

- (3) In the event that a Surveyor issues a Surveyor Report at the mandatory port, the Surveyor is required submit Surveyor Report as referred to in paragraph (1) immediately after the Report Surveyor published.
- (4) In case the Surveyor issues. Surveyor Report in other than the mandatory port, the Surveyor is required submit Surveyor Report as referred to in paragraph (1) no later than 1 (one) week after the Surveyor Report is published.

Article 13

- (1) Forestry industry company and / or company trade as referred to in Article 3 must submit a report on the realization of Product Exports Forestry industry both realized and not realized every 1 (one) year electronically to the Director General through the Director of Exports Agriculture and Forestry Products.
- (2) The realization report as referred to in paragraph (1) be delivered through the page <http://inatrade.kemendag.go.id> no later than the date 15 months of February the following year.
- (3) The form of the realization report as referred to in paragraph (1) is listed in Attachment III which is an inseparable part of the Regulation This minister.

Article 14

- (1) Surveyors are required to submit recapitulation reports implementation of Verification or Search activities Technical Export of Forestry Industry Products as referred to in Article 9 paragraph (1) in a manner manual to the Director General through the Director Exports of Agriculture and Forestry Products with copy to the Director General of Agro Industry Ministry of Industry.
- (2) Manual report as referred to in paragraph (1) submitted no later than the 15th (fifteenth) the following month.

Article 15

- (1) Companies that do not carry out obligations as referred to in Article 13, is subject to Administrative sanctions in the form of revocation:
 - a. Industrial Registration Certificate or Business License Industry, NIB for industrial companies forestry; or
 - b. Trading Business License, NIB for trading company in the export sector Forestry Industry Products.
- (2) Imposition of sanctions as referred to in paragraph (1) is carried out by an official issuing licensing based on recommendations and the Director General.

Article 16

- Surveyors who do not carry out obligations:
- a. as referred to in Article 9 paragraph (2) is subject to sanctions in the form of revocation of the right to receive service fees for Product Verification or Technical Search Forestry Industry; and
 - b. as referred to in Article 12 and Article 14 be subject to sanction of revocation of stipulation as implementing Verification or Product Technical Search Forestry Industry.

Article 17

(1) Provisions on the export of forestry industry products in

This Ministerial Regulation is excluded from exports

Forestry Industry Products which are:

- a. passenger luggage or crew facilities
carrier;
- b. sample items sent through the organizer
post and not for trading;
- c. goods for research purposes and
science development;
- d. promotional items for outdoor exhibition purposes
the country is not for trade;
- e. goods as grants, gifts or gifts
for charitable, social or cultural purposes;
- f. imported goods that are refused by the buyer and then
exported the same amount at most
with Notification of Imported Goods (PIB);
and / or
- g. goods for necessity agency
government / other state institutions exported
itself by government agencies / institutions
referred to.

(2) Exceptions as referred to in paragraph (1)

letter b up to letter g can be done

after obtaining approval from the Director General.

(3) The Director General grants the authority mandate

issuance of approval as intended

in paragraph (2) to the Director.

(4) To obtain approval as intended

on paragraph (3) individual and / or

companies / government agencies / institutions must

submit written application to the Director

General by attaching a recommendation from technical ministry and / or legality document other supporters.

- (5) Exceptions as referred to in paragraph (1) only valid for one shipment.

Article 18

When this Ministerial Regulation comes into force, Surveyor which has been designated as the executor of Verification Or Technical Traceability of Forestry Industry Product Exports based on the Minister of Trade Regulation Number 84 / M-DAG / PER / 12/2016 concerning Export Provisions Forestry Industry Products (State **Gazette** of the Republic Indonesia Year 2016 Number 2006) as already amended several times, the last by Ministerial Regulation Trade Number Number 38 / M-DAG / PER / 6/2017 concerning the Second Amendment to the Ministerial Regulation Trading Number 84 / M-DAG / PER / 12/2016 concerning Forestry Industry Product Export Provisions (News Republic of Indonesia Year 2017 Number 844) in the maximum period of 3 (three) months from This Ministerial Regulation shall apply in accordance with provisions in this Ministerial Regulation.

Article 19

When this Ministerial Regulation comes into force, the Regulation Minister of Trade Number 84 / M-DAG / PER / 12/2016 concerning Provisions on the Export of Forestry Industry Products (State Gazette of the Republic of Indonesia Year 2016 Number 2006) as amended the last several times with Regulation of the Minister of Trade Number 38 / M-DAG / PER / 6/2017 concerning the Second Amendment above

Regulation Minister Trading. Number
84 / M-DAG / PER / 12/2016 concerning Export Provisions
Forestry Industry Products (State Gazette of the Republic
Indonesia Year 2017 Number 844), revoked and declared
not applicable.

Article 20

This Ministerial Regulation shall come into force after 3 (three) months

TECHNICAL CRITERIA USED TO DETERMINE PRODUCTS

CERTAIN FORESTRY INDUSTRIES THAT CAN BE EXPORTED

1. Size and level of preparation

a. Processed wood in the form of S4S (*surfaced four side*) included

HS.4407:

Processed wood products are flattened all four sides so that the surface becomes flat and smooth.

- derived from merbau wood with the provisions that the cross-sectional area is no more than 10,000 mm².
- derived from other than merbau wood with the provisions of the cross-sectional area no more than 4,000 mm².

b. Processed wood in the form of E2E or E4E which includes HS.4409:

Processed wood products derived from S4S that are curved at 2 (two) angles (E2E) or 4 (four) angles (E4E) with angular provisions curve of at least 3 mm (R3).

- derived from merbau wood with the provisions that the cross-sectional area is no more than 10,000 mm².
- derived from other than merbau wood with the provisions of the cross-sectional area no more than 4,000 mm².

c. *Finger Jointed* which includes HS.4407 :

Processed wood products produced by connecting sawn wood which has been dried and typed on four sides after the *finger* process *jointed* with the length of each piece that is connected is not more than 1,000 mm.

d. *Decorative Profile* which includes HS.4409:

Processed wood products produced by forming wood with
moulder machine , *in* such a way that it displays the function of beauty

(*decorative* function) and can be used immediately without changing the form,

except cut it to the required length, with

the following conditions:

1) The cross-sectional area size is not more than 12,750 mm²;

2) For *Decorative Profile* Width:

- *decorative* at least half (1/2) wide face on

one side;

- not more than 25 mm thick, *decorative* depth of at least -

lack of 3 mm;

- thickness of more than 25 mm to 50 mm, *decorative* depth of at least -

lack of 6 mm;

- more than 50 mm thick, *decorative* depth of at least

10 mm.

3) For thicker *Decorative Profiles*:

decorative at least half (1/2) thick face on

one side;

width no more than 50 mm, *decorative* depth of at least

lack of 3 mm;

width of more than 50 mm to 80 mm, *decorative* depth of at least

lack of 6 mm;

width of more than 80 mm to 100 mm, *decorative* depth

at least 15 mm;

width of more than 100 mm, *decorative* depth of at least

20 mm.

For a *Decorative Profile* with a cross-sectional area of less than

1,000 mm² are not subject to size and depth requirements

the decor.

If there are profiles on 2 (two) sides, the depth of the profile is

the sum of these 2 (two) sides.

e. Profile wood for *Door Jamb* or *Window*

Jamb) which includes HS.4409:

With the provisions that the cross-sectional area is not more than 7,200 mm².

f. Wood Profile for *Door Frame* or *Window Frame*

(Window Frame) which includes HS.4409:

With the following conditions :

- thickness not exceeding 40 mm;
- cross-sectional area not more than 6,600 mm².

g. *Wall Panel* included HS.4409:

Has a thickness of no more than 20 mm with a cross-sectional area no more than 4,000 mm² in the form of tongue and groove (*tongue and groove*), the groove and the groove (*groove and groove*) or *shiplap*, with provisions as follows:

- width not exceeding 50 mm, having a groove and tongue height or *shiplap* of at least 2 mm;
- Width of more than 50 mm to 100 mm has a groove and height tongue or *shiplap* of at least 3 mm;
- width of more than 100 mm has a groove and tongue height or *shiplap* of at least 5 mm.

h. *Flooring* included HS.4409:

Has a thickness of no more than 35 mm with a cross-sectional area no more than 7,000 mm² in tongue and groove (*tongue and groove*), the groove and the groove (*groove and groove*) or *shiplap*, with provisions as follows:

- width not exceeding 50 mm, having a groove and tongue height or *shiplap* of at least 2 mm;
- width of more than 50 mm to 100 mm has a groove and height tongue or *shiplap* of at least 3 mm;
- width of more than 100 mm has a groove and tongue height or *shiplap* of at least 5 mm.

i. Decking included HS.4409:

Has a thickness of no more than 45 mm and a cross-sectional area no more than 9,000 mm², provided that:

from the types of merbau, keruing, kempas, bangkirai, lime, ironwood and balau;

Thickness not more than 20 mm has deep *reeded / groove* on side width of at least 1.5 mm;

thickness of more than 20 mm to 35 mm has a deep *reeded / groove* on the wide side of at least 3 mm;

thick more than 35 mm to 45 mm have deep *reeded / groove* on the wide side of at least 5 mm.

If there is a *reeded / groove* on 2 (two) sides then the depth *reeded / groove* is the sum of the 2 (two) sides.

At least half the surface width must be *reeded* or given 2 (two) *grooves* with proportional distance along the length the wood.

Jâ € ¢ *Flooring for Truck, Container, Ship Deck and Wagon* included HS.4409:

In the form of *tongue and groove* or *shiplap*, with the following conditions:

of merbau, keruing, kempas and bangkirai wood;

thick not more than 50 mm;

the cross-sectional area is not more than 12,000 mm²;

- Deep groove and tongue height and depth of *shiplap* at least-lack of 5 mm.

Special *pole, play sill, cross sill* and *truck body* must be accompanied by

drawings that contain complete technical specifications (picture sets installed) and must be exported together with the *flooring*.

k. Wood building elements which are a unitary unit of

Building (H S.4418):

Must be in the form of a set of building elements accompanied by a loading image complete technical specifications without changing shape and cut it off.

l. Prefabricated Buildings from wood (HS.9406):

Must be in the form of prefabricated building sets accompanied by drawings which contains complete technical specifications without changing shape and cut it off.

m. *Post and Beam* which includes HS.4409:

Processed wood products in the form of E4E and given a *reeded / groove*, with the following conditions:

the cross-sectional area of not more than 4,500 mm² has *reeded / groove* on 2 (two) sides, with depth on each side at least 2 mm;

the cross-sectional area of not more than 8,100 mm² has a *reeded / groove* on 4 (four) sides, with depth on each side at least 2 mm;

cross-sectional area above 8,100 mm² up to 14,400 mm² have *reeded / groove* on 4 (four) sides, with depth on each side of at least 4 mm.

n. *Window Board* that includes HS.4409

With the following conditions:

- one of the thick sides is given the formation of a *bullnose* profile (curved in half

- circle);
- has a thickness of no more and 30 mm;
- cross-sectional area no more and 7,800 mm².

2. Tolerance of size and disability

- a. All sizes of processed wood exported are given a size tolerance as follows:
 - thickness not exceeding 0.5 mm;
 - width of no more than 1 mm;
 - length not exceeding 50 mm.
- b. Defects due to machining (*machine - defect*) are not allowed more than 5% of the total volume exported.
